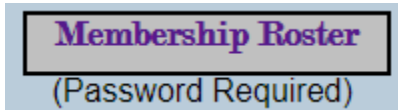


SIR 93 Roster Book – Go to the SIR 93 Officers / Committees Web Page
